SERVICES COMMON TO EVERY CONSULATE

- Passport issuance and renewal
- Consular identification (matrícula, DPI, DUI, cédula)
- Birth, marriage and death certificates
- Powers of attorney
- Document legalization / apostille
- Emergency assistance and help in detention cases

BEFORE YOU GO: PRACTICAL TIPS

- Almost every consulate now requires an online appointment; walk-ins are rarely served.
- Bring originals AND copies of every document; many offices do not make photocopies on site.
- Payment is frequently by money order or cashier's check only - call ahead to confirm which methods are accepted.
- The consulate can help you with civil documents and identification, but it cannot represent you in U.S. immigration court or file forms with USCIS - that is what your immigration attorney is for.
- Hours and even addresses change. Always confirm the address, the hours and the required documents on the website listed before you travel.

About appointments: Most of the consulates in this guide require an online appointment through each country's official appointment portal (listed on that country's page). Very few accept walk-ins only.

Each consulate issues passports, the consular ID card (matrícula consular), birth/marriage certificates, and powers of attorney. - Exact payment in the accepted form - usually a money order or cashier's check, rarely cash or card

Guatemala has 26 consulates in the United States, including 11 passport printing centers. All consular service payments are made ONLY by money order - cash, checks, and cards are not accepted.

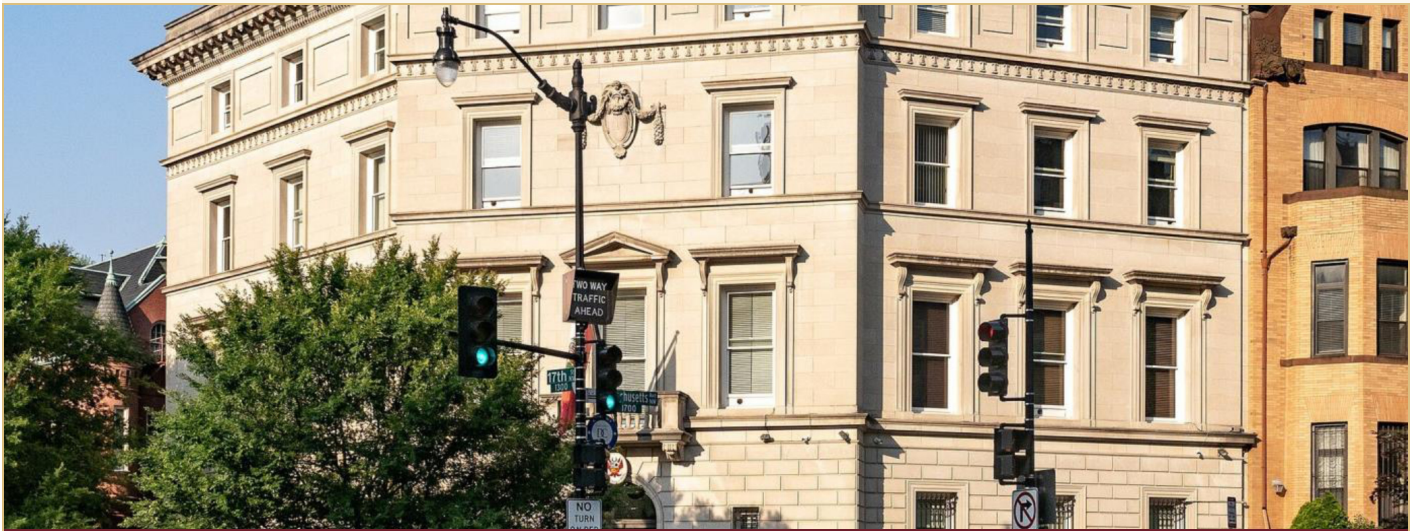
